  - i. Pilot Program: Washington is piloting a program (which may start happening in Oregon and California) where they are trying to watch mileage use for cars along the I-5 corridor. Newer cars are more fuel-efficient and don't needs as much gas as much as the older cars; with less gas is being used, fewer taxes on gas are paid, which results in less money to fix the roads. The idea behind the





mileage pilot program is to start adding a surcharge on electric cars and cars that get better gas mileage so that everyone is paying their fair share toward fixing the roads that all are using.
