- I. The meeting was called to order at 5:28 p.m. by Matt Hilton.
- II. Roll was taken by Jennifer Barker.
- III. Guests: Our Local 328 lost-timers and the various organizers from Council 75 and the International introduced themselves and spoke a bit about how AFSCME Strong Week has been going.
- IV. Officer Reports
 - a. Treasurer's Report: See submitted reports.
 - i. Email Motions: The board approved emm#20151120 on Nov. 20, 2015, to spend \$5,200 from project charter funds to purchase advertising on benches at two bus stops at OHSU. The board approved emm#20151211 on Dec. 11, 2015, to spend \$300 to send Local 328 members to the Council 75 Women's Conference.
 - ii. Financial-Standards Workshop: The AFSCME financial-standards workshop will be held in Wilsonville on March 12. Details can be found on the Council 75 website.
 - iii. Loan Principal Payment: Christi Branchaw moved and Sarah Cinnamon seconded to make a loan principal payment of \$100,000, paid from the contract-defense fund. This is money that was already pledged to cases—there would be no additional costs. Paying more on principal now will mean lower mortgage payments in the future. Christi recommends moving the funds because we're over the FDIC limit and the other remedy would be to open another account. After discussion, the question was called. **Motion passed unanimously.**

IX. New Business

- a. Board Seats
 - i. Building Manager Board Position: Christi moved and Michael Stewart seconded to convert the at-large board position currently held by Mike Bandy to a designated building-manager position. After discussion, the question was called. **Motion passed unanimously.**
 - ii. Unit Stewards Board Position: Matt moved and Christi seconded to appoint Chris Fosnight to this position (moving from at-large). After discussion, the question was called. **Motion passed unanimously.**
 - iii. Trustee: Linda moved and Christi seconded to appoint Nate Leviner as a trustee. After discussion, the question was called. **Motion passed unanimously.**
- b. Presidential Endorsement: Council 28 in Washington has just endorsed Bernie Sanders, breaking with the International's endorsement of Hillary Clinton. Matt wanted to discuss with the board a possible endorsement of Bernie Sanders by Local 328. There was discussion re: whether there would be any associated expenditures, what it would mean for the local to make an endorsement this early, and the impact an endorsement now could have on the MOM-card campaign. Christi moved and Linda seconded to table the discussion to a future date. **Motion passed unanimously.**
- c. Incidents During AFSCME Strong Week: There was an issue at an AFSCME Strong Week tabling event in Sam Jackson Hall today involving an outside organizer that escalated to the point that Dan Forbes and Hollie Hemenway from OHSU Human Resources became involved. The area in question is considered patient care and is generally not available for tabling, etc., but we had notified HR and been given the okay. The outside person will not be allowed back on OHSU property. Matt noted that he had emailed Hollie three times about scheduling rooms for AFSCME Strong Week and didn't get a response. In addition, OHSU has filed a ULP due to what they perceive as a Local 328 staff representative who is interrupting workflow.

- XI. Seeing no additional business before the body, it was moved by Jennifer and seconded by Matt to adjourn the meeting. **Motion passed unanimously.** Matt Hilton adjourned the meeting at 6:07 p.m.
